

# MINUTES FOR MEETING

AUGUST 12, 2010

THE FOLLOWING PEOPLE WERE IN ATTENDANCE: RICH, DAN, LAURIE,  
AMY, RUTH, LYNDA, DIANE, CINDY, DARRYL, GARY

**CALL TO ORDER:** THE MEETING WAS CALLED TO ORDER AT 10:30AM  
**APPROVAL OF THE MINUTES:** THE MINUTES FOR THE JUNE MEETING  
WERE APPROVED BY THE BOARD.

**FINANCE REPORT:** THE CURRENT BALANCE AS OF AUGUST 13<sup>TH</sup> WAS  
\$3349.64. FGCC TOOK IN ABOUT \$100 IN DONATIONS FOR ICE TEA AND  
LEMONADE AT PRIDE. THE FINANCE REPORT WAS APPROVED BY THE  
BOARD

**MEMBERSHIP REPORT:** ACTIVITY FROM JULY 12-AUGUST 12 SHOWS  
THAT FGCC ADDED 4 NEW COUPLES TO MEMBERSHIP AND DELETED 3  
COUPLES FOR NON-RENEWAL. THE UPDATED DATABASE WAS  
FORWARDED TO BOTH MEDIA COUPLE AND THE VICE-CHAIR COUPLE. THE  
MEMBERSHIP COUPLE EXPRESSED CONCERN THAT OLDER MEMBERS ARE  
NOT RENEWING. CUURENT MEMBERSHIP IS ABOUT 74 COUPLES.

**OLD BUSINESS:** THE BOARD STARTED DISCUSSION ABOUT THE FALL  
FLING. I WAS SUGGESTED THAT WE CONTACT MARY AND BARBARA TO  
SEE IF THEY ARE INTERESTED IN HOSTING SUCH EVENT. IT WAS ALSO  
DISCUSSED THAT THE FALL FLING COULD BE A FGCC SPONSORED EVENT.  
THE BOARD AGREED THAT THEY WOULD LIKE FOR THE ANNUAL FALL  
FLING TO CONTINUE. CINDY OFFERED TO CALL BRENDA AND KAREN TO  
INQUIRE ABOUT THE USE OF THEIR HOME. AT THE SAME TIME, THE  
BOARD AGREED TO SEND OUT A GLOBAL TO SOLICATE POSSIBLE  
LOCATIONS FROM OUR MEMBERSHIP.

**NEW BUSINESS:** DIRECT DISCUSSION STARTED RELATING TO THE LACK OF  
ACTIVITIES ON THE CALENDAR. THE BOARD DECIDED TO SEND OUT A  
GLOBAL OFFERING EVENT SUGGESTIONS TO OUR MEMBERSHIP TO HOST.  
THE BOARD ALSO AGREED TO CO-HOST ANY EVENT THAT NEEDED  
ASSISTANCE.

SINCE DECEMBER IS RIGHT AROUND THE CORNER THE EVENT  
COUPLE WOULD LOOK INTO HAVING THE EVENT HELD AGAIN THIS YEAR  
AT STREET CAR CHARLIES. THEY WILL ALSO LOOK INTO HAVING THE  
EVENT HELD IN THE 1<sup>ST</sup> OR 2<sup>ND</sup> WEEK IN DECEMBER.
